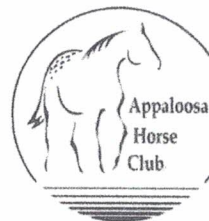


Horsemanship Score Sheet

Scoring: 0-100 with 70 denoting the average. Maneuvers are scored +3 to -3 in 1/2 point increments

Minor Faults (-1 points):

- Break gait at walk or jog for up to 2 strides
- Over/under turn from 1/8 to 1/4
- Ticking or hitting cone
- Obviously looking down to check leads

Major Faults (-3 points):

- Break of gait at lope, out of lead or missing lead for 1-2 strides
- Not performing gait or not stopping when called for in pattern within 10' of designated area
- Incorrect lead
- Break of gait at walk, jog for more than 2 strides
- Loss of stirrup
- Head carried too low and/or behind vertical while horse is in motion, showing intimidation

Severe Faults (-5 points):

- Loss of rein
- Use of either hand to instill fear or praise while on pattern or rail work
- Holding saddle with either hand
- Cueing with the end of the romal
- Blatant disobedience
- Spurring in front of the cinch

Disqualification:

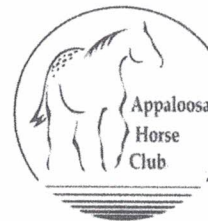
- (Except Walk/Trot and Novice classes)
- Going off pattern
 - Knocking over cone
 - Not performing designated gait or lead
 - Over or under turn of more than a 1/4 turn
 - Illegal use of hands on reins

Minor Faults (-1 points):

- Break gait at walk or jog for up to 2 strides
- Over/under turn from 1/8 to 1/4

Major Faults (-3 points):

- Break of gait at lope, out of lead or missing lead for 1-2 strides
- Not performing gait or not stopping when called for in pattern within 10' of designated area
- Incorrect lead
- Break of gait at walk, jog for more than 2 strides
- Loss of stirrup
- Head carried too low and/or behind vertical while horse is in motion, showing intimidation

Severe Faults (-5 points):

- Loss of rein
- Use of either hand to instill fear or praise while on pattern or rail work
- Holding saddle with either hand
- Cueing with the end of the romal
- Blatant disobedience
- Spurring in front of the cinch

Disqualification:

- (Except Walk/Trot and Novice classes)
- Going off pattern
