Penalties


- Error / Penalty 1/4**
- Tick of leg, pole, cone, plant or obstacle
- Error / Penalty 1**
- Hit or step on • Incorrect or break of gait at walk or jog 2 strides or less
 - Both feet in space • skip space • split pole
 - Failure to meet correct strides

- Error / Penalty 3**
- Incorrect or break of gait at walk or jog over 2 strides • Out of lead or break of gait at lope • Knockdown • Step out or jump off with one foot (After entering)
- Error / Penalty 5**
- Step Out or jump off with two or more feet (After entering) • Drop object • 1st refusal or evade • Dropping Gate • Blatant disobedience • 2nd refusal or evade • Instill fear or praise • Holding saddle horn

Disqualification

- Error / Penalty 0**
- Work obstacle wrong • Wrong line of travel • Working outside course boundary • 3rd refusal or evade • Dropping the rope gate and not picking it up • Fail to complete obstacle • Excessively or repeatedly touching horse • Overturns of more than 1/4 turn No attempt to perform obstacle • Performing obstacles out of order • In-hand Horse gets loose or leading on the wrong side
