### Penalties

- Error / Penalty 1/4**
- Tick of log, pole, cone, plant or obstacle
- Error / Penalty 1**
- Hit or step on
  - Incorrect or break of gait at walk or jog 2 strides or less
  - Both feet in space • skip space • spli. pole
  - Failure to meet correct strides

### Penalties

- Error / Penalty 3**
- In correct or break of gait at walk or jog over 2 strides
  - Out of lead or break of gait at lope
  - Knock down
  - Step out or jump off with one foot (After entering)
- Error / Penalty 5**
- Step Out or jump off with two or more feet (After entering)
  - Drop object
  - 1st refusal or evade
  - Dropping Gate
  - Blatant disobedience
  - 2nd refusal or evade
  - Instill fear or praise
  - Holding saddle horn

### Disqualification

- Error / Penalty 0**
- Work obstacle wrong
  - Wrong line of travel
  - Working outside course boundary
  - 3rd refusal or evade
  - Dropping the rope gate and not picking it up
  - Fail to complete obstacle
  - Excessively or repeatedly touching horse
  - Overturns of more than 1/4 turn
  - No attempt to perform obstacle
  - Performing obstacles out of order
  - In-Hand: Horse gets loose or leading on the wrong side
